These cookies are used to enable you to use the Website, to enable us to analyse your visit and use, and to improve our services. The cookies are stored in your browser folder on your PC, laptop, tablet, smart phone and/or mobile device.

We provide more specific information below on what cookies are and describe in detail which are necessary cookies, functional cookies and Google Analytics cookies.

What is a cookie?

We make use of cookies at this website. A cookie is a small, simple text file that is sent by a server and saved on the hard disk of your computer by your browser when you view the pages of this website. The information saved there can be sent back to our servers when you visit the website again.

Cookies can be installed by the server of the website that you visit or by partners of that website. The server of a website can only read the cookies that it has installed itself and has no access to other information on your computer or mobile device. The cookies are stored in a specific browser folder on your computer and/or mobile device. A cookie usually consists of the name of the server that placed the cookie, an expiry date and a unique number code.

In general, cookies make the interaction between the visitor and the website faster and simpler and help the visitor to navigate between the different parts of a website. Cookies can also be used to make the content of advertisements on a website more relevant for the visitor and can be adjusted to the visitor's personal tastes and requirements.

Management of cookies

Most browsers are set up to accept the cookies used on our Website. However, you can adjust the parameters of your browser to exclude these cookies. If you exclude cookies, it is possible that certain parts of the Website will not be shown correctly or that some applications cannot be used.

- **Direct cookies** These cookies are placed directly and are managed by Honda Motor Europe Logistics NV, with its corporate seat at Langerbruggestraat 104, 9000 Ghent, Belgium, with company number 0418.250.835 (referred to below as 'Honda').
- Third party cookies These cookies are placed and managed by other parties, such as Google Analytics. They are placed during your visit to the website at www.hondamotoreuropelogistics.com. They ensure that certain information is sent to third parties via your visit to the website www.hondamotoreuropelogistics.com.

Different types of cookies

- **Necessary cookies:** these cookies are essential for visiting our website and for the use of certain parts of the website. For example, with these you can navigate between the different parts of the website or complete forms. If you reject these cookies, certain parts of the website will not work or will not work or optimally.
- Functional cookies: functional cookies are cookies that make it easier to enable the website to function, make navigating more convenient for visitors and ensure a more personalised browsing experience. For example, these cookies can remember your language choice.
- Analytical cookies: we use analytical cookies to gather information on the use of our website by visitors (pages viewed, average length of the visit, etc.), with the intention of improving the content of our website, adjusting the website more closely to the requirements of visitors and to improve the usability of our website. For analyses of the use of our website, we also use Google Analytics, which also uses cookies for this purpose. These cookies can be both anonymous and non-anonymous. The use of non-anonymous cookies for analysis purposes is requested in advance. You can therefore refuse to allow these cookies to be placed on your computer, laptop, tablet, smart phone or mobile device by changing your cookie settings via Cookie Manager. Google can provide this information to third parties if Google is required to do so by law, or in as far as third parties process the information on behalf of Google. We have no influence on this. We have **not** permitted Google to use the analytics information gathered for other Google services.

The information that Google gathers is anonymised as far as possible. Your IP address is explicitly not shared. Google transfers the information to and saves it on servers in the US. Google states that it complies with the Privacy Shield principles and is affiliated to the Privacy Shield programme of the US Department of Commerce. For how long are cookies saved?

- Use of permanent cookies With the aid of permanent cookies, we can recognise you on a new visit to our website. As a result, the website can be set up especially for your preferences. Your rights
